### JERSEY POLICY

#### JERSEY POLICY

This season, PLMHA is making it mandatory that all jerseys be taken care of by 'jersey caretakers' which consists of a maximum of 2 families. One family will care for the home jerseys and one for the away jerseys. Players are NOT permitted to transport their own individual jerseys, no exceptions.

#### Purpose:

This policy has been developed to ensure that hockey jerseys are cared for and maintained in such a manner to ensure that the jerseys last from season to season and reduce the necessity of replacement.

#### Responsibility:

~ Parents and players are to review and sign off that they understand the requirements of the jerseys and agree to adhere to them.

This shall be signed and returned to the team manager prior to the teams first game.

~ Parents are required to review the jersey images on the back of this page and make any notations of markings found on the jersey prior to use. Parents will not be held responsible for marks/damage indicated on this form.

#### Parent / Player Requirements

~ PLMHA requires that players drink ONLY clear fluids when wearing the PLMHA provided game jerseys. If a player is given a coloured drink (i.e. Gatorade) and the liquid spills on to the jersey causing it to become stained, the parents of that player will be held responsible and invoiced for either the cost of dry-cleaning the jersey(s) and or the total cost of both jerseys to allow the association to replace them.

~ At no time shall game jerseys be worn for team practices.

~ At no time shall any player ask or request that PLMHA game jerseys be worn for events that are not PLMHA/team related, such as school jersey days. If the event is a team event (i.e. fundraising event), then PLMHA will support that. Should any jersey become damaged or stained because of said event, then again, the parents will be held responsible and invoiced for the cost of either dry-cleaning or when applicable, to cost to replace both jerseys.

~ Sponsorship information, if applicable, shall not be covered by any other sponsor bars or name bars.

#### Affixing Name Bars to Jerseys

~ PLMHA recommends that name bars be sewn on by hand using a loose stitch. If parents choose to have them sewn on professionally or by use of a sewing machine, then the parents are responsible for ensuring that they are removed professionally to avoid any tearing of the jersey. If a jersey sustains a tear/rip because of name bars not being removed professionally, the parents of the player that wore that jersey number will be invoiced for the cost to replace both jerseys, NO EXCEPTIONS.

Note: If any family is invoiced due to improper use/care of the jerseys, and it is not paid, the amount owing will be indicated on the player's Hockey Canada file and that player nor any other member in the family, will be permitted to register for the next hockey season until the invoice is paid.
